SESSION PAYMENT PLAN OPTION- Swimmer's who would like to sign up for specific sessions may do so. This option does not include USA Swimming registration, bathing suit or club t-shirts, *unless* you are committing to the entire 06-07 payment plan and total amount due. You must state your intentions on the registration form. If you do commit to the six sessions and your plans change, you will be responsible and charged for the retail value of the USA registration, bathing suit and two T-shirts, no matter when you cancel.

NOTICE OF SESSION PAYMENT PLAN OPTION- Session Payments renew automatically and must be paid via credit cards. Credit cards will be charged two weeks prior to the beginning of the next session. Credit Cards must be on file with NSSC.

NOTICE OF ESCROW ACCOUNT RENEWAL: All escrow accounts must be maintained with a positive \$100.00 balance. To ensure this, all families are required to supply a credit card for escrow account transactions. Escrow accounts will renew automatically on a session to session basis with the escrow account being charged to a positive \$100.00 balance two weeks prior to a new session.

NOTICE OF PROGRAM CANCELLATION- Credit Cards will be charged two weeks prior to the beginning of the next session, unless written notification of cancellation is given to NSSC prior to the charging of your credit card. There will be no refunds of tuition registration without prior written notification of cancellation of a minimum of two weeks before a new session.

NOTICE OF INSURANCE- Competitive Athletes must be registered under the North Shore Swim Club, USA swimming umbrella. This is a once per year fee. Non Competitive/ Learn to swim athletes of the North Shore Swim Club must be registered under the North Shore Swim Club, non competitive umbrella. This is a per session fee.
